Errata and Revisions of DC/TMD Documents

Feb 6, 2020

- On the Diagnostic Criteria table, Myofascial Pain" was revised back to "Myofascial Pain with Spreading", in order to reconcile the table with the decision tree previously updated based on recommendation by an INfORM member. (See July 4, 2018 entry.)
- The Diagnostic Criteria table, the Assessment Instrument package, and the .zip package are updated to reflect some prior changes that were not incorporated into the Assessment Instrument package.

July 4, 2018

- On the Diagnostic Criteria table, for Disk Displacement with Reduction, Examination E7 was clarified by adding "(protrusive or lateral)" for the type of click expected to fulfill criterion.
- On the Decision tree, change "Myofascial pain" to "Myofascial pain with spreading" based on recommendation by an INfORM member, in order to make the language parallel in structure with that for "Myofascial pain with referral"; otherwise, "myofascial pain" would appear to subsume "myofascial pain with referral", which is not the intent. These names are clearly in flux and warrant further investigation and nomenclature development.

Apr 25, 2018

- Both North American and International DC/TMD examination forms (including field for diagnoses) incorrectly listed a diagnosis as "Dislocation"; the proper term is "Subluxation". This was corrected in 2017 but the updated forms were never uploaded to the website. That error is now corrected.
- The individual forms, the Assessment Instrument package, and the .zip package are updated.

Jan 9, 2017

Document "DC-TMD Self-report Instrument Scoring Manual_2014_06_06" contained an error in Appendix 2, where the "GAD-7" had received a typo in the form of "PHQ-7". This was fixed, and some line spacing and header format in the same table was addressed. The initial document date of 2014 in the filename was a typo; it should have been 2016.

Sept 5, 2016

• On the Decision Tree, page 2, add "By examiner" to the joint noise box in the path for disc displacement with reduction diagnosis, in order to distinguish noise identified by the examiner, vs noise identified by the patient, as indicated clearly in the box at the top of the slide. This change is also consistent with what was already in place for the DJD diagnostic path.

Oct 23, 2015

 Document "DC-TMD - Diagnostic Criteria_2014_01_21.pdf", version 5/25/2014, (indicated in the top portion of the document) was noted to have incorrect sensitivity and specificity values; source of the error is unknown but is assumed to reflect preparation of the table prior to final sensitivity and specificity estimates were computed for the published DC/TMD. • Corrected version placed on website, with version date 10/23/2015 (indicated inside the document).

- Added diagnostic criterion note to Headache Secondary to TMD, with regard to necessity of either a myalgia or arthralgia diagnosis in order to have a secondary headache.
- Corrected minor punctuation discrepancies.

April 29, 2014

 On the Diagnostic Criteria table, corrected name of disorder "myofascial pain"; was incorrectly stated as "myofascial pain with spreading". While the latter is descriptive, as operationalized within the DC/TMD diagnostic structure, "myofascial pain" is the formal term established by Travell and Simons.
